3. ADDITIONAL COSTS AND DESIGN APPROVAL PROCESS

Any circumstances leading to additional costs, such as rush delivery fees, expedited revisions, or requests for design concepts beyond the initial scope, will be clearly detailed. Moreover, the process for design approval will be clearly defined, emphasizing the client's responsibility to provide timely feedback and approval at each stage of the project. Delays in approval may impact project timelines and result in additional charges.

4. CLIENT RESPONSIBILITIES AND REVISION POLICY

The Client is responsible for promptly reviewing all deliverables provided by GMedia Digital Marketing ("Service Provider") upon receipt. When revisions to previously completed and updated designs are necessary due to customer failure or negligence in providing timely feedback or approval, additional corrective action charges may apply. These charges will be billed at a rate of \$100 per hour with a minimum charge of \$70. Additionally, the number of revisions included in the project scope will be clearly outlined. For instance, the initial project fee may cover up to three rounds of revisions, with any further revisions incurring additional charges.

5. INTELLECTUAL PROPERTY RIGHTS AND USAGE RIGHTS

All designs, content, or materials created by GMedia Digital Marketing shall remain its intellectual property until full payment is received from the Client. Upon receipt of full payment, ownership of the final design(s) will transfer to the Client, granting them the right to use the design(s) for their intended purposes. However, the original design files remain the property of GMedia Digital Marketing and cannot be requested by the customer. Additionally, usage rights for the final design(s) will be specified, including any restrictions on modification, reproduction, or distribution.

6. TERMINATION POLICY

Client may terminate this Agreement by providing written notice to GMedia Digital Marketing ("Service Provider") at least one month in advance of the intended termination date. GMedia Digital Marketing does not refund partial monthly payments. Cancellation only applies after the 30-day cancellation waiting period is over. The client will be charged for any work done during the 30-day cancellation period. Additionally, GMedia Digital Marketing will communicate to the client at least one month in advance of the effective date of the price change.

7. TIMELINE AND DEADLINES

Both GMedia Digital Marketing ("Service Provider") and the Client will agree upon specific project timelines and deadlines for deliverables. This ensures that both parties have a clear understanding of when work will be completed. Any changes to the agreed-upon timelines will be communicated promptly and agreed upon by both parties.

8. FORCE MAJEURE

In the event that either party is unable to fulfill its obligations under this Agreement due to circumstances beyond their control, such as natural disasters, acts of war, government regulations, or other events commonly referred to as "force majeure," the affected party shall promptly notify the other party in writing and provide details of the circumstances preventing performance. The affected party will be excused from performance for the duration of the force majeure event, and the timelines for deliverables will be extended as necessary to accommodate the delay caused by the force majeure event.

9. SUBCONTRACTORS

GMedia Digital Marketing may, at its discretion, use subcontractors to perform certain services outlined in this Agreement. Any subcontractors engaged by GMedia Digital Marketing will be required to adhere to the same standards and obligations as outlined in this Agreement. GMedia Digital Marketing will remain fully responsible for the performance and deliverables of subcontractors and will ensure that subcontractors maintain confidentiality and comply with all relevant terms of this Agreement.



10. CONFIDENTIALITY

Each party agrees to keep confidential any proprietary or confidential information disclosed by the other party during the term of this Agreement.

11. REPRESENTATIONS AND WARRANTIES

Each party represents and warrants that it has the full right, power, and authority to enter into this Agreement and to perform its obligations hereunder.

12. LIMITATION OF LIABILITY
